## Massive Online Open Course - Trust and Action Project

The Trust and Action MOOC focuses on Framework Decisions 2008/947/JHA and 2009/829/JHA at both the European and national levels.

It can be freely accessed at the following link: https://elearning.unito.it/mooc/course/index.php?categoryid=5 [1]. The course provides the participants with key information on the functioning of these instruments of judicial cooperation and on their implementation in Italy, Romania and Spain.

The MOOC is addressed to a vried range of beneficiaries, such as students, volunteer of vicil society organisations, prison staff, lawyers, judges and public prosecutors.

It is divided into various sections. The introductory one offers an overview of the main principles and techniques governing judicial cooperation in criminal matters in the EU.

The second and the fourth ones address Frameowrk Decisions 2008/947/JHA and 2009/829/JHA respectively, whereas the third and the fifth provide an in-depth analysis of the implementation of these acts in the Member States concerned.

The materials published in this website can be a useful complement to the Trust and Action MOOC.

The RePers research consortium has developed an e-learning tool providing the necessary tools to cope with Fr 2008/947/JHA and 2009/829/JHA, and with the challenges that they pose.

both under EU law and domestic (Italian, Romanian and Spanish) implementing legislations - are explained.



It provides an in-depth analysis of the content and the functioning of these instruments, which are mutually complementary and contribute to the development of an ever advanced system of European judicial cooperation in criminal matters.
